JUNE 19, 1993 Roundtable Pizza Federal Way

The meeting was called to order at 1:30 p.m. by President, Jane Moore. There were 19 people attending: Jane Moore, Hugh Moore, Steve Peterson, Steve Freeborn, Kathy Casey, Jeanette Vallandigham, Walt Reid, Karen Jost, Jan Kavadas, Suzi Ness, Tom Foley, Francine Harmeson, Tammi Keeler, Robin O'Leary, AnnaMarie Terhaar, Phoebe Terhaar, Jeanne Ensign, Mark Pembrooke, and arriving late, trying to shirk his duties, Frank Newquist. There were nine teams represented: Federal Way Masters; OOPS, Fort Steilacoom; Tacoma Y; Cascade; ORCA; Tigers; Issaquah Y; and Queen Anne Swim Club.

Jane began the meeting by passing out....address lists of the PNA Board to those who had not yet received them.

Minutes for the May meeting were approved as written.

REPORTS

Treasurer

Tammi reported a balance of \$6,77.06 in the PNA account and \$2,931.40 in the Wiggin Fund. M/S/A 93.86 to Suzi Ness to reimburse mailing costs for bid packets and M/S/A up to \$300.00 to Francine Harmeson for envelopes. Jane (our ex-treasurer) finally got to wrap it all up, (presented the final financial report for Long Course Nationals), the bottom line being a net profit of \$4,028.86. Way to go everyone!

Membership

Francine reported we **stayed** at 538 with approximately 14 new members in the past month. The policy for reducing USMS registration fees was reviewed, because we now run on calendar years. M/S/A that the reduction in fees will be effective six months prior to the end of the registration year. Therefore, effective July 1, the fees will be \$22.50 for those under 65, and \$19.00 for 65 plus.

<u>Meets</u>

Bids have been slow and late getting to Suzi. (We all seem to thrive on paperwork and deadlines, don't we?) The following meets were accepted by those in attendance following discussion.

October 30, 1993, GLAD will host the Short-Course Meter Zone Champs, tentatively at Helene Madison.

November 21, 1993 (tentative), Queen Anne Swim Club will host a "Swim Rally." All swimmers do 500, 400, 300, 200, and 100 yard freestyle; i.e., your choice of style ... estimating their times, and those swimmers coming closest to their total times will win.

February 12, 1994, GLAD will host the Fred Wiggin Memorial Meet, consisting of the 1,000 freestyle, 400 IM, and 800 free relay.

February 13, 1994, ORCA will host a "regular" meet at the Queen Anne Pool.

Meets (Continued)

Hugh Moore advised the group that FWM will host the PNA Champs on April 8, 9, and 10, 1994. Karen brought up using transfers onto tee-shirts that will show the swimmers placing in events as <u>awards</u>. Further, a \$20.00 surcharge to cover entry fee, events, shirt, heat sheet, and social was discussed. (See enclosed sheet for "meet budget" - PNA Champs.) M/S/A (that's real clever ... I like it) for the transfers and surcharge.

Karen also requested that FWM not pay PNA for awards at Champs. M/S/A.

M/S/A for FWM to host LC zones on July 23 and 24. The meet will start Saturday afternoon, and have a regular starting time on Sunday.

M/S/A for GLAD to host the Short Course Zone Champs on October 30, 1993.

Hugh Moore requested that FWM be allowed to reduce its surcharge payment to the PNA so that FWM could break even on the recent LC Meet, as he was projecting a loss at that time. Further, he asked to delay payment to PNA until the bill from KCAC arrives. M/S/A as Hugh had requested.

Walt Reid advised the group that Greg Harrison had requested approval for a USS Meet. M/S/A which included appointing Greg as observer and waiver of the approval fee.

Jane discussed Long-Distance Championship swims at the following distances: 1.5, 3.0, 6 plus miles, or 10. These are postal meets. Ted Waldron volunteered to chair a committee to run such a meet.

The Oregon swim meet was moved to July 31 and August 1. The deadline for meet entries is July 17.
