Problems included bounced email addresses, ISP that don't accept attachments, and attachments that don't print properly. **MSA to allocate \$200 to send renewal notices to approximately 500 members who have not renewed from years prior to 2004.**
- **C. Zone Meeting Report & Open Water Update:** Zone polices were reviewed at the recent zone meeting. The LMSCs are currently voting on whether to establish Zone Open Water Championships.
- **D. 2005 Champs/NW Zone SCY Meet:** MSA fees for Champs of \$16 surcharge + \$2 for event. There is also a \$1 per swimmer zone surcharge.
